- Knowledge and strong research interest in function of the central nervous system, including molecular basis of these processes, and in particular the development of neuroimmune disorders;

- 6. Advanced practical knowledge of biochemical and molecular techniques (i.e., Western Blot, ELISA, Luminex, qRT-PCR, immunohistochemistry);

INFORMATION CLAUSE ON PERSONAL DATA PROCESSING

Pursuant to Article 13 and 14 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and the free movement of such data and repeal of Directive 95/46/EC ("General Data Protection Regulation"), hereinafter referred to as the "Regulation", the Maj Institute of Pharmacology notifies that:

- 1. The Maj Institute of Pharmacology of the Polish Academy of Sciences, 12 Smetna Street, 31-343 Kraków, represented by the Director of the Institute, shall be the Administrator of your personal data.
- 2. The Maj Institute of Pharmacology of the Polish Academy of Sciences is appointed the Data Protection Officer, e-mail: <u>iod@if-pan.krakow.pl</u>, phone: 501 979 962.
- 3. Your personal data in the scope indicated in the provisions of the labor law (including, inter alia, in the scope resulting from Article 22¹ § 1 of the Labor Code) will be processed pursuant to Article 6 paragraph 1 point c (processing is necessary to fulfill the legal obligation incumbent on the administrator) and Article 6 paragraph 1 point b of the GDPR (processing is necessary to take steps at the request of the data subject before concluding the contract), and in the remaining scope pursuant to Article 6 paragraph 1 point a of the GDPR (consent of the data subject).
